



## Notice to All Land Owners: Debris on Town Roads

With a wet spring anticipated there is a greater potential for the accumulation of mud and other debris on town roads caused by vehicles and equipment entering and existing agricultural fields. Not only can this damage the vehicles of other drivers it can cause dangerous road conditions and accidents.

The Town Board wants to remind residents to promptly remove and clean any accumulations of mud or other debris which come from their property by their actions or any other person acting with the permission of the property owner.

Failure to promptly remove or clean town roads may result in fines against the responsible property owner pursuant to §86.04 of the Wisconsin Statutes. If town roads are damaged by any means including by the accumulation of mud and debris the responsible party may be held liable for up to three times the cost of any necessary repairs pursuant to §86.02 of the Wisconsin Statutes. Please be mindful of other motorists and keep our town roads clean and clear.
